NOTE TO NOVICE EXHIBITORS

You must change your entry from Novice A to Novice B once your dog earns its first title in any class. Note that this is NOT considered a move-up but rather an entry change. However you make this change **ONLY** if trial entries have not closed. If trial entries have closed, you will remain in the class you originally entered. Remember – once a trial has closed, you cannot change your Novice entry. Even if you elect to submit a move-up to Open for the class in which you received your first Novice title, you will remain in Novice A in the remaining class(es) if entries have closed.

ENTRY METHOD: FIRST RECEIVED

ENTRIES OPEN ON Wednesday, July 14, 2010, 8 a.m. at the Trial Secretary's address. All entries received before this date will be returned. **No hand-delivered, USPS Express Mail, or courier-delivered mail accepted.**
ENTRIES CLOSE ON Wednesday, August 25, 2010, 6 p.m. after which time entries cannot be accepted, cancelled, altered, or substituted except as provided for in Chapter 11, Section 6 of the Rules Applying to Dog Shows. Envelopes/transactions containing entries for more than the ten (10) dog maximum and/or entries received prior to the opening date shall be treated as an invalid entry and shall be returned to the sender.

OBSTACLES AND RING CONDITIONS

Obstacles meet the specifications for obstacles in the current edition of the Regulations for Agility Trials. We will be using weave poles with 22" spacing. All classes will take place indoors on a packed dirt surface. Ring size is 90 x 100 feet each.

All exhibitors should obtain a copy of the Regulations for Agility Trials by contacting the American Kennel Club, 8051 Arco Corporate Dr. Suite 100, Raleigh, NC 27617-3390, by email to info@akc.org, or on their website at www.akc.org.

DOGS ELIGIBLE TO ENTER

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number, or approved Foundation Stock Service (FSS) breeds are eligible to participate.

Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Wherever the word "dog" is used in these regulations it includes both sexes.

Dogs should be physically sound. Dogs that are blind or deaf shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate. Puppies under six months of age are strictly prohibited from the trial grounds.

MEASURING & HEIGHT CARD INFORMATION

Effective January 1, 2010, exhibitors are no longer required to provide proof to Trial Secretaries that their dog has a valid jump height card as part of the check-in process. Furthermore, this change eliminates the need for a copy of the jump height card to be submitted with an entry form. Dogs without a valid Jump Height Card/Form may still compete; but they must be measured/wicketed by the **Judge of Record** PRIOR to running in their class and this measurement will be valid for that weekend of trials only. The exception to this requirement is a dog entered in the 24" or 26" height division. However, if a **Volunteer Measuring Official (VMO)** or an **Agility Field Rep** is present; **ALL** dogs without a valid Jump Height Card/Form must be measured at some time during the trial or cluster of trials. This does not preclude having the dog wicketed by the Judge of Record if the VMO or Rep is not available to measure the dog **before** its first run of the trial or cluster of trials. It is the exhibitor's responsibility to have their dog measured prior to running and failure to do so will result in the cancellation of any qualifying scores.

NEW Simplified Jump Height Card Process

When filling out the entry form, there is a new section at the top of the form for exhibitors to designate whether your dog has a valid jump height card or if your dog needs to be measured. Please check the appropriate box so that the Trial Secretary knows whether to include your dog on the *Dogs To Be Measured List*. It is no longer required that you submit a copy of your dog's jump height card with your entry form or show it during day of show check-in.

COURSE WALK-THROUGHS AND WARM-UP INFORMATION

Handlers in all classes are permitted to walk the course, without a dog, during a walk-through period held prior to the start of the class. The walk-through is restricted to handlers entered in that class only. **A warm-up area**, consisting of a regulation agility jump, may be provided for exhibitors. The warm-up area is to be used exclusively for warming up the dog and not for training or relieving of the dog.

RIBBONS, AWARDS, AND PRIZES

Dalmatian Club of North Texas will offer green qualifying strip ribbons will be awarded for all qualifying scores. Rosettes will be awarded to 1st through 4th place dogs in each class/jump height. 1st place winners in each class/jump height also will receive a coupon for a discounted entry at a future DCNT agility trial. MACH/PAX winners and new title winners will receive special rosettes. Dogs must qualify to receive a placement. Awards must be claimed at the trial; none will be mailed.

The Trial Secretary will send email confirmations to exhibitors who provide a **legible** email address on their entry forms. Printed confirmations will be mailed to those without email addresses.

UPSP Express Mail and/or courier-delivered entries **NOT** accepted. Only First Class or USPS Priority Mail is acceptable. Inquiries may be directed to Dianna Barefoot at talewaggin@gmail.com. No entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance. **Illegible entries** will not be processed and will be returned to the exhibitor. Returned checks do not constitute a valid entry and the Trial Secretary will add a **\$25** collection fee to the amount of each returned check. **The Trial Secretary** does not accept electronically-submitted entries from any online entry service. Entries filled out using an online entry service must be printed and mailed to the Trial Secretary's post office address supplied elsewhere in this premium.

MOVE-UP POLICY

Move-ups are permitted prior to the trial as long as they are in writing and received no later than 6 p.m. on the Monday preceding the event. Email move-ups are acceptable. Day-to-day move-ups are allowed provided the move-up form (available at the trial) is submitted no later than 20 minutes after the last dog has crossed the finish line. If you do not complete a move-up form, you may **NOT** move-up the next day – **NO exceptions!**

NOTICE TO EXHIBITORS

SAFETY, BEHAVIOR and LIABILITY: The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely. **It is expressly understood** that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. Dalmatian Club of North Texas and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The Dalmatian Club of North Texas reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the Dalmatian Club of North Texas or any official thereof. **All dogs must be on leash** at all times when on trial grounds except when in the designated warm-up area or competing on the course.

REFUNDS: No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee. **Bitches in season** are not permitted to compete in Agility Trials. The club will offer a full refund less \$10/day processing fee for bitches that come into season after the closing date.

RINGSIDE: Dogs may arrive any time prior to judging, if a valid copy of their jump height card was sent with their entry. Otherwise, they must be available for measuring prior to the start of their class. **Judges are not required** to wait for dogs. The owner of each dog is solely responsible for having it ready at ringside when it is to be judged. The Club has no responsibility

for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

- Smoking is not allowed in any building in the Will Rogers Complex. All children **MUST** be accompanied by an adult at all times.
- The trial site will be available to exhibitors the day of the trial at 6:30 a.m. The trial committees reserve the right to alter this time depending on weather conditions and/or the condition of the building.
- No mats are allowed in the upper level crating areas. Mats may be used in the lower level (dirt) crating areas.
- Exhibitors are expected to comply with all Club rules as laid out and enforced by the Dalmatian Club of North Texas.
- Dogs may not be exercised outside the trial building or sidewalks or paved parking lots of Will Rogers Memorial Complex, the Museum or the Art Center. Areas to exercise your dog(s) will be designated.
- Dogs must not be tied to bushes, shrubs, trees or other permanent fixtures.
- No unentered dogs are allowed on grounds.
- Exhibitors may wear shirts or insignia of their training group.
- The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all the obstacles safely.
- Exhibitors are responsible for complete, accurate and legible information on their entry forms; illegible or incomplete entries will not be accepted.
- **BITCHES IN SEASON ARE NOT PERMITTED IN THE TRIAL, AND DCNT WILL REFUND ALL BUT \$10 PER DAY OF ENTRY FEES FOR BITCHES IN SEASON. THE TRIAL SECRETARY MUST RECEIVE WRITTEN VETERINARY CERTIFICATION NO LATER THAN 30 MINUTES PRIOR TO THE START OF THE 1ST CLASS OF THE DAY. REFUNDS WILL BE MAILED AFTER THE CLOSE OF THE EVENT.**
- Exhibitors are responsible for being at the gate when it is their turn to run.
- Dogs may not be left in the building overnight.
- DCNT, and the City of Fort Worth will not be responsible for the loss of or damage to any dog exhibited, or for possessions of any exhibitor, whether the result of an accident or any other cause. It is distinctly understood that every dog at this show is in the care and custody of its owner or handler during the entire time the dog is in the trial buildings or on the grounds at Will Rogers Memorial Complex. The welfare of an exhibitor's child is assumed to be the responsibility of the exhibitor. It is distinctly understood that exhibitors will exercise control and restraint over their children on the day(s) of the trial.
- No gasoline or diesel generators are permitted inside any building.
- The Dalmatian Club of North Texas is not responsible for the actions or products of the caterers at this trial.
- Crating areas are on a first come, first served basis. No crating inside any building may be reserved or saved by roping off, placing cones, chairs, tables, equipment or any other means you may think to employ.
- Exhibitors and handlers will be held responsible for clean conditions in and around their dogs' crates.

PARKING CHARGE

As of May 2010, vehicles that park @ WRMC complex will be charged a \$5.00 parking fee in all of the parking facilities, including the NEW garage providing an additional 1,117 new parking spaces.



AGREEMENT

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other persons. **I (WE) AGREE THAT ANY CAUSE OF ACTION, CONTROVERSY OR CLAIM ARISING OUT OF OR RELATED TO THE ENTRY, EXHIBITION OR ATTENDANCE AT THE EVENT BETWEEN THE AKC AND THE EVENT-GIVING CLUB (UNLESS OTHERWISE STATED IN ITS PREMIUM LIST) AND MYSELF (OURSELVES) OR AS TO THE CONSTRUCTION, INTERPRETATION AND EFFECT OF THIS AGREEMENT SHALL BE SETTLED BY ARBITRATION PURSUANT TO THE APPLICABLE RULES OF THE AMERICAN ARBITRATION ASSOCIATION. HOWEVER, PRIOR TO ARBITRATION ALL APPLICABLE AKC BYLAWS, RULES, REGULATIONS AND PROCEDURES MUST FIRST BE FOLLOWED AS SET FORTH IN THE AKC CHARTER AND BYLAWS, RULES, REGULATIONS, PUBLISHED POLICIES AND GUIDELINES.**

INSTRUCTIONS

Handlers may opt to enter in a higher **height division** for all **Regular** titling classes, but not in a division lower than their proper height division.
