### • TRIAL INFORMATION

- Bitches in season are not permitted in the trial, and DFWDC and GCKC will refund all but \$5 per day of entry fees for bitches in season. The Trial Secretary must receive written veterinary certification no later than 30 minutes prior to the start of the 1<sup>st</sup> class of the day. Refunds will be mailed after the close of the event.
- Exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committees, be asked to leave the trial site. In such case, no refund of entry fees will be made.
- Exhibitors are responsible for being at the gate when it is their turn to run.
- DFWDC, GCKC, and the Trial Secretary have no obligation or responsibility to provide a public address system or stewards to call or locate dogs that are not present at the ring when required.
- Dogs may not be left in the building overnight.
- DFWDC, GCKC, and the City of McKinney will not be responsible for the loss of or damage to any dog exhibited, or for possessions of any exhibitor, whether the result of an accident or any other cause. It is distinctly understood that every dog at this show is in the care and custody of its owner or handler during the entire time the dog is in the trial buildings or on the grounds at Myers Park & Event Center. The welfare of an exhibitor's child is assumed to be the responsibility of the exhibitor. It is distinctly understood that exhibitors will exercise control and restraint over their children on the day(s) of the trial.
- No gasoline or diesel generators are permitted inside any building. No propane heaters are allowed.
- The DFW Dachshund Club, Inc. and the Greater Collin Kennel Club, Inc. are not responsible for the actions or products of the caterers at this trial.
- Crating areas are on a first come, first served basis.
- Exhibitors and handlers will be held responsible for clean conditions in and around their dogs' crates.
- Absolutely no exercise pens will be allowed on the parking lots. A grass area to exercise dogs will be provided. Dogs must be exercised only in the designated areas.

### COURSE FAMILIARIZATION AND WARM-UPS

- Handlers are permitted to walk the course, without a dog, prior to the start of the class.
- All obstacles conform to the requirements in the most current edition of the AKC Regulations Applying to Agility.

### RIBBONS & ROSETTES

Both clubs will offer green qualifying strip ribbons which will be awarded for all qualifying scores. Rosettes will be awarded to 1<sup>st</sup> through 4<sup>th</sup> place dogs in each class/jump height. MACH, PAX and new title winners will receive special rosettes. MACH & PAX winners will receive a jump bar. Dogs must qualify to receive a placement. Awards must be claimed at the trial; none will be mailed.

### RING DIMENSIONS

Both Standard and JWW rings are 90 x 100 (approximately 9,000 square feet). The surface is packed dirt, and the trial site is an indoor, non air-conditioned arena.

### ARMBAND REQUIREMENT

All competitors **MUST** wear armbands while running. Competitors will not be admitted to the rings without their exhibitor armband(s) visible.

### EXHIBITOR INFORMATION

- Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.
- Smoking is not allowed in the building.
- All children **MUST** be accompanied by an adult at all times.
- The trial site will be available to exhibitors the day of the trial at 6:30 a.m. The trial committees reserve the right to alter this time depending on weather conditions and/or the condition of the building.
- Exhibitors are expected to comply with all Club rules as laid out and enforced by the DFW Dachshund Club and the Greater Collin Kennel Club.
- Areas to exercise your dog(s) will be designated.
- Dogs must not be tied to bushes, shrubs, trees or other permanent fixtures.
- All dogs present **must** be on leash or confined in crates when not being judged.
- No unentered dogs are allowed on grounds. No puppies under the age of six months are allowed on the trial grounds.
- Exhibitors may wear shirts or insignia of their training group.
- The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all the obstacles safely.
- Exhibitors are responsible for complete, accurate and legible information on their entry forms; illegible or incomplete entries will not be accepted.

### Entry Fees Both Trials

DAILY entry fees are \$22 for the 1<sup>st</sup> entry of a dog (which includes the \$3 AKC recording fee) and \$12 for the 2<sup>nd</sup> entry of the same dog (which includes the additional \$3 AKC event service fee).

### DAILY MOVE-UPS

Day-to-day move-ups are allowed at this set of trials. If you complete a title and would like to move up, you must submit a move-up form no later than 30 minutes following the close of that day's trial. Move-up forms (printed on brightly colored paper) will be available at the check-in table. Dogs moving up will run at the end of the new class. You may not move up if you do not complete a move-up form on the day on which you qualify.

### AKC JUMP HEIGHT CARDS

All agility dogs are required to have an Official Jump Height Card/Valid yellow form and exhibitors must present the card(s) at any time during the trial upon request. If a Volunteer Measuring Official (VMO) or an Agility Field Rep is present; ALL dogs without a valid Jump Height Card must be measured at some time during the trial. However, this does not preclude having the dog measured by the Judge of Record if the VMO or Rep is not available to measure the dog before its first run of the trial. It is the exhibitor's responsibility to have their dog measured prior to running and failure to do so will result in the cancellation of any qualifying scores.

**New Simplified Jump Height Card Procedure:** The entry form has a section at the top for exhibitors to designate whether their dog has a jump height card or if their dog needs to be measured. Please check the appropriate box so that the Trial Secretary knows whether to include your dog on the *Dogs to be Measured List*. **It is no longer necessary to submit a copy of your dog's jump height card with your entry or show it during check in the day of the trial.**

### ENTRY INFORMATION

- **NO HAND-DELIVERED, COURIER OR USPS EXPRESS MAIL ALLOWED!** Regular or Priority USPS mail accepted at P.O. Box Only. Mail to any other address will be returned. **Limit: 10 entries per envelope. One entry = one dog.** Envelopes containing more than 10 entries will be returned.
- Owners are responsible for ensuring that entry forms are completed IN FULL. Entries submitted without ALL information may be returned as invalid.
- All entries must be submitted on official AKC agility entry forms, one dog per entry form. Photocopies of entry form will be accepted only if legible and official AKC size. Entries will not be accepted without signature, fees and back of entry form with agreement signed, nor will credit cards or faxed entries be accepted.
- Exhibitors are responsible for complete, accurate, and legible information on their entry forms; illegible or incomplete entries will not be accepted
- Returned checks do not constitute a valid entry; no refund for duplicate entries.
- Entry fees will not be refunded if a dog is absent, disqualified, excused or barred from competition by Trial Committee action. Entry fees will not be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, acts of God, public emergency or any other cause beyond the control of the committee.

### ENTRY CONFIRMATIONS/JUDGING PROGRAMS

An initial email confirmation is sent only if the email address is *legibly printed* on the entry form. If you cannot receive a Word attachment, or if you do not check your email, do NOT include your email address. Printed confirmations are mailed to exhibitors without email addresses. Contact the Trial Secretary by phone, fax or email to report errors. **Correct registration # or ILP/PAL # is crucial for crediting qualifying scores.**

The Judging Program and a final entry confirmation is emailed to the owner's address. If you want this information sent to the handler (if different from owner), please specify on your entry. Contact the Trial Secretary if you do not receive the Judging Program within five (5) days of the trial.

### HEIGHT DIVISIONS FOR REGULAR & PREFERRED CLASSES

### TRIAL HOURS - ALL TRIALS

The building will be open at 6:30 AM. Self-service check-in will begin at 7 AM each day. Judging will begin no earlier than 8 AM on all trial days. Exact running order will be determined after entries close and will be provided in the Judging Program. Two rings will be running simultaneously. This set of trials uses electronic timers.

### DOGS ELIGIBLE TO ENTER

This trial is open to all dogs (meaning either sex) 15 months of age or older that are registered with the AKC or that have AKC Limited Registration, Indefinite Listing Privileges (ILP), Purebred Alternate Listing (PAL), or an Approved FSS Breed. Dogs eligible for entry in the Miscellaneous Class may participate provided they are AKC-registered. Bitches in season, aggressive dogs, dogs that are blind or deaf or suffering from any deformity, injury or illness that may affect their physical or mental performance may not be entered.

### CLASSES & TITLES OFFERED

Please see the AKC Regulations for Agility Trials for current class descriptions. Dogs must be entered only in Regular Classes or Preferred Classes with no cross-over between classes allowed at the same set of trials.

#### DIRECTIONS TO THE TRIAL SITE

The town of McKinney is about 33 miles northeast of downtown Dallas on U.S. 75/North Central Expressway. From the north or south: On U.S. 75, take the U.S. 380 exit and go west about 2.5 miles to FM 1461. Turn right (north) on FM 1461 and travel approximately 3.8 miles to County Road 166. Turn right (north) on County Road 166 and go about 0.8 miles to the site which is on the left. The county has posted directional signs to the Event Center.
